**Subject: Notifications of Final Determinations of an Expiry Review of Anti-Dumping Measure on Imports of Certain Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel and of an Expiry Review of Anti-Dumping Measure on Imports of Painted Hot Dip Galvanized of Cold Rolled Steel and Painted Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel originating in the Socialist Republic of Vietnam**

The Department of Foreign Trade (DFT) presents its compliments to the Embassy of the Socialist Republic of Vietnam and wishes to refer to the DFT's letter No.0309/357 dated 2<sup>nd</sup> February 2023 informing the disclosure of essential facts for the draft final determinations of anti-dumping investigations on the above-mentioned proceedings.

In this connection, the DFT would like to take this opportunity to further inform that the Committee on Dumping and Subsidy has made final determinations as follows:

1. To terminate the AD measure on imports of Certain Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel (GL) originating in the Socialist Republic of Vietnam which includes 32 HS codes classified under the Thai Customs Tariff code (HS codes 2022).
2. To renew the AD measure on imports of Painted Hot Dip Galvanized of Cold Rolled Steel and Painted Hot Dip Plated or Coated with Aluminium Zinc Alloys of Cold Rolled Steel (PPGI/PPGL) originating in the Socialist Republic of Vietnam which includes 39 HS codes classified under the Thai Customs Tariff code (HS codes 2022) by applying AD duty at the rate of 4.30 – 60.26% of CIF price for another 5 years in order to prevent the continuation or recurrence of dumping and material injury to the domestic industry.

Pursuant to the Anti-Dumping and Countervailing Act B.E. 2542 and its amendment and the Article 12.2 of WTO Anti-Dumping Agreement, the Committee's notifications of final determination of anti-dumping measures on the products concerned for both aforementioned cases were announced and publicized in the Royal Thai Government Gazette on 8<sup>th</sup> May 2023, and a related Notification of the Department of Foreign Trade was also announced and publicized in the Royal Thai Government Gazette on 8<sup>th</sup> May 2023.
